ERIE PARKING AUTHORITY MONTHLY TERMS AND CONDITIONS (PLEASE READ!)

- MONTHLY RATE FOR RENTAL OF PARKING IS DUE AND PAYABLE BY THE 1ST OF EACH MONTH. IF PAYMENT IS NOT RECEIVED BY OUR GRACE PERIOD OF THE 5TH OF THE MONTH, YOUR ACCESS CARD WILL BE LOCKED OUT AND A \$10 FEE WILL BE CHARGED TO REACTIVATE.
- IF YOUR ACCESS CARD WAS USED DURING OUR GRACE PERIOD AND NO PAYMENT WAS RECEIVED, THE \$10 DAILY MAXIMUM WILL BE DUE FOR EACH DAY OF USE. IN THIS CASE YOU WILL ALSO FORFEIT YOUR CARD DEPOSIT.
- CARD DEPOSITS WILL BE REFUNDED ONLY IF CARDS ARE REUSABLE AND NOT DAMAGED.
- FOR ACCOUNTING PURPOSES, THE MONTHLY RENTAL PERIOD RUNS FROM THE 1ST OF THE MONTH UNTIL THE LAST DAY OF THE MONTH.
- NO REFUNDS WILL BE ISSUED FOR TERMINATED CONTRACTS OR UNUSED DAYS IN THE MONTH. IF YOU DO NOT WANT TO PARK DURING THE COURSE OF A MONTH, PLEASE RETURN YOUR CARD TO CLOSE THE ACCOUNT AND AVOID THE REACTIVATION FEE.
- ATTENDANTS ARE NOT AUTHORIZED TO MAKE OR ALLOW EXCEPTIONS TO THE TERM, CONDITIONS AND REGULATIONS.
- THIS IS A SELF-PARKING GARAGE/LOT. PARK AT YOUR OWN RISK. THIS IS A LICENSE AND NOT A BAILMENT. IN CONSIDERATION OF FURNISHING YOUR PARKING SPACE, YOU AGREE TO THE CONDITIONS ON THE AUTHORIZATION AND THAT THE ERIE PARKING AUTHORITY SHALL NOT BE LIABLE FOR DAMAGE RESULTING FROM INJURIES OF LOSS TO YOU, OTHER PERSONS ACCOMPANYING YOU, YOUR VEHICLE, OR ANY CONTENTS THEREIN. YOU HEREBY WAIVE AND RELEASE THE ERIE PARKING AUTHORITY FROM ANY CLAIM FOR SUCH DAMAGED OR LOSS, WHETHER RESULTING FROM FIRE, THEFT, NEGLIGENCE OR OTHERS OR OTHERWISE.
